## CHANGES FOR AUTHORIZATION REQUIREMENTS FOR OPIOID TREATMENT

On August 11, 2023, Trillium Health Resources received notification from the Benefits Team of Division of Health Benefits around the 1915(i) SPA. The notification included language that encouraged approval of the 1915(i) SPA as leverage until the policies included in the SPA could be promulgated. Link to the SPA is below:

## State Plan Amendment (SPA) #: 22-0026

Trillium is working on adding new 1915 i codes to our benefit plan and to providers' contracts. For members approved for 1915(i) services, authorizations will be moved from the current B3 to the 1915(i) codes.
