This Request for Applications (RFA) seeks proposals from qualified organizations or individuals with expertise in TBI, webpage development, and resource compilation.

## 2. BACKGROUND:

Individuals with TBI and their families often face significant challenges in navigating the complex landscape of available resources and support services. A centralized, easily accessible electronic resource guide is crucial to provide timely and accurate information, empowering individuals to make informed decisions and improve their quality of life by accessing necessary services and supports.

## 3. PURPOSE:

The selected applicant will be responsible for the following:

### 4.1. Content Development and Organization:

- 🌱 Conduct thorough research and gather information on TBI, including medical, legal, financial, and support resources within North Carolina.
- 🌱 Organize content into logical and user-friendly categories.
- 🌱 Develop clear, concise, and accessible content, adapting it for various reading levels and cognitive abilities.
- 🌱 Incorporate multimedia elements (e.g., videos, infographics) to enhance understanding.

### 4.2. Resource Directory Development:

- 🌱 Compile a comprehensive database of local, regional, and state TBI resources.
- 🌱 Develop search and filtering options for easy resource retrieval.
- 🌱 Implement a system for regular updates and maintenance of the resource directory.

### **4.3. Testing and Quality Assurance:**

- 🌱 Conduct thorough functionality, accessibility, and user acceptance testing.
- 🌱 Implement a process for ongoing feedback and updates.

### **4.5. Training and Documentation:**

- 🌱 Develop user training materials and CMS training documentation.
- 🌱 Provide technical documentation for the platform.

## **5. ELIGIBILITY:**

Applicants must demonstrate:

- 🌱 Expertise in TBI and related services.
- 🌱 Experience in website/platform development and database management.
- 🌱 Knowledge of accessibility guidelines and best practices.
- 🌱 Strong research, writing, and communication skills.
- 🌱 Experience in developing and implementing CMS based guides.

## **6. APPLICATION REQUIREMENTS:**

Applicants must submit the following:

### **6.1 Cover Letter:**

A brief introduction of the applicant organization or individual and a statement of interest and qualifications.(limit 1 page)

### **6.2. Project Proposal**

A detailed description of the proposed electronic resource guide, including content organization, platform design, and resource directory development. This description must include a description of how ADA accessibility will be addressed, a plan for testing, evaluation, and ongoing maintenance and a timeline for project completion. (limit 4 pages)

### **6.3. Budget:**

A detailed budget outlining all project costs.

### **6.4. Qualifications:**

Resumes or CVs of key personnel. Examples of previous website/platform development projects. Letters of support from relevant organizations or individuals.

## 7. EVALUATION CRITERIA:

Applications will be evaluated based on the following criteria:

- 🌱 Applicant qualifications and experience doing this type of work.
- 🌱 Quality and comprehensiveness of the proposed electronic resource guide.
- 🌱 Feasibility of the platform design and development plan.
- 🌱 Strength of the resource directory and maintenance plan.
- 🌱 Budget reasonableness.
- 🌱 Demonstrated commitment to accessibility.
