THE ASAM TRAINING PROJECT FOR NORTH CAROLINA

The Division of Health Benefits NC Medicaid and the Division of Mental Health, Developmental Disabilities and Substance Abuse Services (DMH/DD/SAS) are pleased to offer a variety of opportunities to participate in *The ASAM Criteria Training*. This training project is a part of the 1115 Substance Use Disorder Demonstration Waiver implementation plan. The plan includes: 1) the use of *The ASAM Criteria* to determine the appropriate level of care required for beneficiaries and 2) ensuring direct enrolled professionals providing comprehensive clinical assessments (CCA), diagnostic assessments (DA) and other evaluations have the knowledge, skills and ability to make an ASAM level of care determination for beneficiaries with a substance use disorder diagnosis.

AUDIENCE

These training opportunities are exclusively for behavioral health clinicians in North Carolina (LP, LPA, LCSW, LCSW-A, LCMHC, LCMHC-A, LCAS, LCAS-A, CCS, LMFT, LMFT-A, PA, NP, MD) who are contracted with an LME/MCO or a Standard Plan to provide CCA, DA, and other evaluations.

TRAINING OPTIONS

Live Training

Train for Change, Inc®, in collaboration with UNC School of Social Work–Behavioral Health Springboard (BHS) and Northwest AHEC, will facilitate this **live online two day**, application-focused training that provides participants with an in-depth look at the theoretical foundations of the Criteria, including clinically driven services, biopsychosocial assessment, the six dimensions, continued stay and transfer/discharge criteria.

As part of the training, all participants receive an in-depth Training Journal to guide the training experience and as a resource for continuing skill application.

Skills that reinforce the module's learning objectives are practiced and applied through interactive case studies and followed up with review from Chief Editor of *The ASAM Criteria*, Dr. David Mee-Lee.

ASAM Module 2 - From Assessment to Service Planning and Level of Care (5.0 CEUs)

Hosted by Dr. David Mee-Lee, Chief Editor of *The ASAM Criteria*

This course helps practitioners understand how to work with a participant's assessment and service planning to identify the best level of care in which to provide his or her services. Skills that reinforce the module's learning objectives are practiced and applied through interactive case studies and Dr. Mee-Lee provides real-world application and description via brief video clips throughout the module.

ASAM Module 3 - Introduction to *The ASAM Criteria* (2.0 CEUs)

This effective and accessible solution for training will serve as a quick orientation and reference guide for the new edition of the American Society of Addiction Medicine's criteria for patient assessment, service planning and level of care placement. *The ASAM Criteria* (2013), now in its Third Edition, introduces new context and content key to the field of addiction treatment.

THE ASAM CRITERIA (TWO-DAY) SKILL BUILDING TRAINING-LIVE INTERACTIVE WEBINAR

This two-day application-focused training provides participants with an in-depth look at the theoretical foundations of *The ASAM Criteria*, including clinically driven services, biopsychosocial assessment, the six dimensions, continued stay and transfer/discharge criteria. Incorporating the use of the new edition of *The ASAM Criteria*, participants will have opportunities for skill practice at every stage of the treatment process: assessment, engagement, treatment planning, continuing care and transfer or discharge. Special attention will be paid to the Opioid Treatment Services (OTS) chapter of *The ASAM Criteria* (2013) that includes Opioid Treatment Programs (OTP) and Office-Based Opioid Treatment (OBOT); and the use of psychosocial treatments for clients receiving opioid use disorder treatment medication. As part of the training, all participants receive an in-depth Training Journal to guide the training experience and as a resource for continuing skill application.

IMPORTANT NCSNAP REMINDERS

All persons served by the State's Developmental Disabilities (DD) System Require an NC SNAP:

- ▲ Assessments should be completed and submitted upon initial contact with the I/DD service system (Provider)
- ▲ Assessments should be updated annually and anytime a significant change has occurred in the individual's needs/level of support

NC SNAPS must be submitted via email or fax:

- ▲ Email: NCSnap@TrilliumNC.org
- ▲ Fax Number: 252-215-6874; 910-353-4954

Ensure NC SNAPS are filled out completely prior to submission:

- ▲ Assessments missing pertinent information (Consumer ID Number, Type of Assessment, etc.) will be returned to the provider for correction
- ▲ Individual's Case Number should be the member's Trillium Case/Record Number
- ▲ Assessments may be completed "by hand" but should be written in clear/legible handwriting (please do not use cursive handwriting)
- ▲ Members' social security numbers should not be recorded on NC SNAPS

Each page of the NC SNAP must be submitted for initial and annual assessments:

- ▲ NC SNAP Summary Report &Supplemental Information forms may be sent in isolation for Discharge NC SNAPS only
- ▲ Incomplete assessments will not be processed, and will be returned to the provider (via email)

Discharge NC SNAPS should be submitted as promptly as possible:

- ▲ Please do not wait until the member is due for an annual NC SNAP update to submit discharge NC SNAP
- ▲ If a member has changed providers, the new provider should be listed on the Summary Report &Supplemental Information page of the NC SNAP

NC SNAPS submitted via email must be sent securely:

- ▲ Members' names/initials should not be listed within the subject line of the email (this is an electronic HIPPA violation)

The date of NC SNAP assessment should reflect the date that assessments are completed:

- ▲ Assessments listing a future date cannot be entered into the database
- ▲ Assessments containing a future date will be returned to the provider for correction

Past-due NC SNAP Notifications are sent out weekly:

- ▲ Please respond to requests for updated NC SNAPS as promptly as possible
- ▲ A Plan of Correction will be issued for providers that fail to submit assessments after the third request has been sent

Necessary corrections to a member's NC SNAP utilizing the following procedures:

- ▲ Corrections should be made by the individual who completed the assessment
 - ▲ One single line shall be drawn through the error, making sure the original entry is still legible
 - ▲ The corrected information shall be recorded legibly above or near the original entry
 - ▲ An explanation as to the type of documentation error shall be included whenever the reason for the correction is unclear
 - ▲ Correction fluid or tape shall not be used for the correction of errors
