### **Trillium Health Resources to present at Columbus Board of Commissioners Meeting**

*County leadership prepares for the move of Columbus County to Trillium catchment area*

GREENVILLE, NC- The Columbus County Board of Commissioners will welcome Trillium Health Resources's CEO Leza Wainwright to their meeting today. The Board plans to discuss the realignment of Columbus County to Trillium's catchment area.

In preparation for the transition, Trillium has held seven listening sessions and one information session for the citizens of Columbus County. At these sessions, community members have been able to meet members of the Trillium staff, ask questions, and express concerns in an open forum. The county leadership and Trillium will utilize the comments and questions collected at these forums in order to guide discussion and plans toward meeting the needs of the community.
