#### ATTENTION All Medicaid Providers

Due to recent legislative revisions, there are several changes that will require providers to update their profiles in NCTracks and how they are submitting claims that will affect both past and future Medicaid payments. At the next Provider meeting on October 20, Trillium will be presenting a general overview of what these changes are in regards to your claims submission, how it may affect you, what steps providers need to take in order to comply and how Trillium can assist you in meeting your obligations. #### Joint Communication Bulletin #J218

Per Joint Communication Bulletin #J218

• Effective November 1, 2016 services delivered by mid-level providers can no longer be billed "incident to." This change was published in the September 2016 Medicaid Bulletin.

• Mid-level providers are Physician Assistants (PAs), Nurse Practitioners (NPs), Certified Registered Nurse Anesthetists (CRNAs), and Certified Nurse Midwives (CNM). These midlevel providers must enroll with N.C. Medicaid and N.C. Health Choice (NCHC). All services provided must be fielded to NC Tracks using their National Provider Identifier (NPI) as the rendering (or attending) provider.

#### NEED TO SEND A SECURE EMAIL TO TRILLIUM?

Over the last month, there has been a significant uptick in the number of *unsecure* emails containing protected health information being sent to Trillium.

As contracted health care providers with Trillium Health Resources MCO, providers are required to abide by all regulations in HIPAA's Final Rule including those pertaining to safeguarding the confidentiality of PHI when it is transmitted electronically.

Attached is a short tutorial that you can share with your staff which explains how you can securely send consumer protected health information to Trillium using Zixmail.

When you access Zixmail through the Provider Portal on Trillium's website, you can compose a email and send it.

Once you type the word, ZIXSECURE in the subject line, the zixmail program encrypts the contents of the email and any attachments.

It does NOT encrypt the subject line. This is where a significant misunderstanding is occurring. No PHI is allowed in the subject line. This includes combinations of consumer initials, names, date of birth, Medicaid or MCO #, etc.
