[Initial Routine Monitoring Post-Payment Review](#)

An Initial Routine Monitoring Post-Payment Review will be conducted on any new service added to an existing contract and certain cross-walked services such as Supported Living and Community Living & Supports. Your Network Liaison will be coordinating this review after the initial 90-day time period. Trillium Health Resources LME/MCO will be randomly selecting up to 10 paid events after 90 days of adjudicated claims for the identified new service that was added to your contract. You will receive a notification letter approximately 28 days prior to the scheduled review.
