# QIP Intervention - Provider Satisfaction Survey

On an annual basis, a survey is conducted of all providers participating in the 1915(b)/(c) Medicaid Waiver program to determine how well MCOs across the state are meeting providers' expectations and needs, and to assess provider perceptions of their respective MCO(s).

Since provider satisfaction is extremely important to Trillium Health Resources, we developed a Quality Improvement Project that is focused solely on improving the overall satisfaction of network providers.

As part of this project to increase overall satisfaction, Trillium periodically surveys the provider network to gauge current satisfaction and to determine what areas need the most improvement and intervention. Up to this point, the number of providers who have chosen to respond to this survey has been low.

This survey was sent out to the provider network on June 1st. We would greatly appreciate you taking the time to participate in the survey. Your feedback is important to us and will help us know how we can improve and what we are doing well!

## New Combined State and Medicaid contract

In response to the MegaRegs\* issued by CMS, Trillium took the opportunity to revise its Network Provider contracts by combining the State and Medicaid contracts into a single document.

Starting in July 2017 Trillium will issue a New Combined State and Medicaid contract.

Trillium will start with those providers who have both State and Medicaid funded services but may include providers who ONLY provide Medicaid funded services and have been reviewed and approved for an extension of the contract.

Trillium will be reviewing all other Provider Contracts and issuing the New Combined Contract in phases until all approved Provider Contracts are on this New Combined Contract template.
