

# **NEW - CREDENTIALING INFORMATION**

## **Credentialing of Team Leads**

Trillium has previously credentialed clinicians who act as team leads for services that are billed using the agency NPI number. Effective June 1, 2016 Trillium will no longer require these clinicians to be credentialed IF the group service is the only service the clinician is delivering. So, clinicians exclusively billing for services as a team lead (using the agency NPI) would NOT be credentialed; however, if that clinician is also delivering a service which requires them to use their own NPI, they DO need to be credentialed to provide the services requiring their individual NPI number to bill.

All currently credentialed clinicians will receive a re-credentialing notification letter approximately 6 months prior to the expiration of privileges. Clinicians that are not required to be credentialed, but nevertheless do not wish for their credentialing to lapse, may still go through the re-credentialing process.

## Change in Credentialing Process - CAQH Electronic Forms

Trillium has posted on its website an electronic version of the <u>credentialing packet</u> to be used with CAQH. Effective June 1, 2016, Trillium will no longer accept paper applications. All documents must be completed and the applicant must have registered and obtained a CAQH number before the packet is submitted. When the complete application is received, the Credentialing team will place the applicant on the CAQH roster and notify the Provider so that the Clinician can complete and upload the CAQH attestation.

When completing the CAQH application, the Clinician must fill in all fields regardless of whether CAQH requires the information. If a field is not applicable, please enter N/A in the blank. Any incomplete applications received will be denied and returned to the provider to be corrected and resubmitted.

#### **Adding Clinicians**

This section applies to clinicians who are required to be credentialed (as above): to add a new clinician to an agency or group practice, please go to the <u>Trillium website</u>, <u>Provider Page/ Provider Documents & Forms/ Credentialing Application Packet</u>. The packet includes the Request to Add Licensed Clinician form and detailed instructions for completing an application using CAQH.

#### **Board Certified Practitioners**

Board Certified MDs, Physician Assistants, and Nurse Practitioners are required to submit a copy of their Board certificate(s) with their credentialing application.

MDs and Physician Assistants who are not Board Certified are required to submit a copy of their transcripts.
