



Attention All Providers - Funding Opportunity

As part of [Trillium's efforts in the opioid epidemic](#), we have added [resources on our website](#) that provide data, available opioid treatment programs, peer support services, and more.

Trillium completes an annual Gaps & Needs Survey to help determine what services are needed in our area. While the full report is not yet available, we did compile the attached "Opioid Crisis: County-Specific Data Packet" that details these statistics by region and county.

Also, we wanted to share about a funding opportunity through the Substance Abuse and Mental Health Services Administration (SAMHSA), Center for Substance Abuse Prevention (CSAP). SAMHSA is responsible for the \$31 million that North Carolina received through the State Targeted Response to the Opioid Crisis Grant.

"SAMHSA is accepting applications for fiscal year [\(FY\) 2017 First Responders- Comprehensive Addiction and Recovery Act \(FR-CARA\) Cooperative Agreements](#). SAMHSA will award FR-CARA funds to states, tribes and tribal organizations, and local governmental entities. Local governmental entities include, but are not limited to, municipal corporations, counties, cities, boroughs, incorporated towns, and townships. The purpose of this program is to allow first responders and members of other key community sectors to administer a drug or device approved or cleared under the Federal Food, Drug, and Cosmetic Act for emergency treatment of known or suspected opioid overdose."

The data shared in the County-Specific report and on the webpages should help any interested parties with applying for this grant. Trillium looks forward to working with partners and providers on this important endeavor.

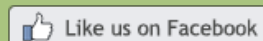

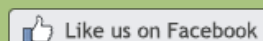

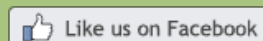
