IX. <u>Director's Report</u>:

Cecelia Peers gave the Director's Report:

- Still waiting on for approval from Kody Kinsley-Director of (NCDHHS), Medicaid Expansion launch is set for October 1st, 2023. This will estimate of additional 4000 new members, based on Budget approval.
- No launch date for Tailored Plan, has been given.
- The Board structure will change depending on how the State divides counties. In moving down to 4 LME/MCO's, this will begin within 60 days once the budget has passed.
- ABC funds have been used with middle and high school students with parents on substance use with providing prevention education. School systems in 4 counties
- Sold out youth information is given through video curriculum, it addresses the emotional health and mental behavior, that leads to substance abuse.
- Under Behavioral Health /IDD services, Trillium operates as a close network, we invite providers in to make sure that we are using their services.
- September 19th we have a virtual summit that is focusing on Suicide Prevention.
- October 24th Trillium is hold a summit with the Hispanic and Latino population in Jacksonville, NC.
- Trillium will be presenting to the Waccamaw Tribe in Columbus County with health education information. November is Native American Heritage Month.

Cecelia shared a Thank you with appreciation letter from Carol Choate- a Caring Heart.
