## TAXONOMY CODE ON CLAIM SUBMISSION FACT SHEET

Incorrect usage and placement of taxonomy codes on claims can cause an increase in denials and rejections. Please use the below information to ensure taxonomy codes are placed on claim forms and electronic segments properly.

### **CMS 1500 FORM SUBMISSION**

- Rendering provider taxonomy code should be placed in box 24J using qualifier ZZ in box 24I
- Billing provider taxonomy code should be placed in box 33b using qualifier ZZ
- Please reference 1500 Claim Form Reference Instruction Manual by the National Uniform Claim Committee

### **837 PROFESSIONAL ELECTRONIC CLAIM SUBMISSION**

- Rendering provider taxonomy code should be placed in Loop 2310B PRV03 using qualifier PXC in PRV 02 as referenced in [837P Professional Health Care Claim](#) document which is also referenced on the Trillium Health Resources website, 'For Providers tab'
- Billing provider taxonomy code should be placed in Loop 2000A PRV03 using qualifier PXC in PRV 02 as referenced in [837P Professional Health Care Claim](#) document which is also referenced on the Trillium Health Resources website, 'For Providers tab'


### **UB04 FORM SUBMISSION**

- For paper claim submissions the Attending provider taxonomy code can be placed in box 76 or 81CCb using qualifier B3.
- For direct data entry into our Behavioral Health I/DD provider portal, Provider Direct, the Attending provider taxonomy code can be placed in box 76.
- Billing provider taxonomy code should be placed in box 81CCa using qualifier B3
- Please reference UB04 Data Specifications Manual by the American Hospital Association and National Uniform Billing Committee.

### **837 INSTITUTIONAL ELECTRONIC CLAIM SUBMISSION**

- Attending provider taxonomy code should be placed in Loop 2310A PRV03 using qualifier PXC in PRV02 as referenced in [837I Institutional Health Care Claim](#) document which is also referenced on the Trillium Health Resources website, 'For Providers tab'
- Billing provider taxonomy code should be placed in Loop 2000A PRV03 using qualifier PXC in PRV02 as referenced in [837I Institutional Health Care Claim](#) document which is also referenced on the Trillium Health Resources website, 'For Providers tab'
